

**2022 Update to  
Volume 15 (Chapters 536-635)  
2021 Oregon Revised Statutes**

Laws enacted at the 2021 second special session of the Eighty-first Legislative Assembly, which convened and adjourned sine die on December 13, 2021, pertain to the subject matter of an ORS chapter in volume 15. Chapter 2, Oregon Laws 2021 (second special session), pertains to the subject matter of ORS chapter 561.

The following tables provide information about laws enacted at the 2022 regular session of the Eighty-first Legislative Assembly, which convened on February 1, 2022, and adjourned sine die on March 4, 2022.
