# HB 5006

SECTION 111. In addition to and not in lieu of any other appropriation, there is appropriated to the **State Department of Energy**, for the biennium beginning July 1, 2021, out of the General Fund, the amount of **\$10,831,296**, for a grant program to incentivize energy efficient rebuilding after the 2020 wildfires.



# INCENTIVE TOTALS

---

## Residential structure:

- Code: \$3,000
- Above code: \$6,000

## Residential structure w/low- or moderate-income addition:

- Code: \$7,500
- Above code: \$15,000

## Manufactured dwelling:

- New energy efficient manufactured dwelling: \$12,500
- Heat pump system installation: up to \$5,000

## Commercial, Public, and Multifamily:

- Code: \$3,000 - \$4,000
- Above code: \$8,000 - \$10,000
- Additional \$500/unit (max \$18,000) for multifamily housing for low-income



# ELIGIBILITY

---

- Must be a structure that was deemed by state or county officials as destroyed or damaged in the 2020 Labor Day fires
- Incentives tied to structures, owners can change
- Available to structures already rebuilt
- Completed local jurisdiction building permit process
- Location:
  - Same property for site-built residential and commercial structures
  - Manufactured homes must be sited within Oregon

# HOW DO I RECEIVE A REBATE?

---

1. Confirm eligibility to participate
2. Complete a digital or paper application
3. ODOE will review, verify application information, and send you a confirmation that funds have been reserved
4. Complete your project
5. Notify ODOE through our program portal or send a completion form by mail to let us know your project is complete. Please include relevant project documentation.
6. ODOE will review and verify your completion form. Following successful verification of a completed application, ODOE will issue the homeowner the approved funds.

- These homes offer improved
  - Windows
  - Insulation
  - Lighting
  - Ventilation
  - Moisture mitigation
  - Air sealing
- Leading to lower energy bills and greater comfort



# REPLACEMENT MANUFACTURED HOME VERIFICATION

---

- Manufactured home retailer
  - Copy of sales invoice
  - Home tracking number
- Building Permits
  - Permit number
- Participation in other programs
  - Oregon Housing and Community Services Manufactured Home Replacement Loan Program.
  - Energy Trust of Oregon Manufactured Home Replacement Program.
  - Utility Incentive Program

# HEAT PUMP SYSTEM

---

- Type of heat pump
- System Requirements
  - Sized appropriately for the structure by a licensed contractor
  - Baseline efficiency of 9.0 HSPF, SEER of 14
  - Manufacturer
  - Model and Serial Number
- Heat Pump Installer
  - Company name
  - Contact information
  - Date of installation
